Strengthening Religious Values Based on Youth Organizations to Prevent Devious Behavior of The Young Generation

Abstract

The challenges of the young generation today are faced with the age of the younger generation itself, where the age of the younger generation is a transitional age from adolescence to adulthood. At this time, of course, the younger generation does not have mature emotional stability, so they are often trapped in situations that lead to deviant behavior, such as drugs, free sex, brawls and other deviant behavior. One solution that can be offered to prevent deviant behavior is through instilling religious values, so this research is urgent to carry out. The aim of this research is to describe how religious organizations implement the cultivation of religious values in an effort to prevent deviant behavior of the younger generation in Wonosobo Regency. The method used in this research is a qualitative research approach which includes stages. The stages of this research method include: (1) preparation; (2) data collection; (3) data analysis; and (4) reflection. The results of this research were that at the beginning of its formation, activities were carried out including joint learning across classes and departments. Through weekly overnight shifts at group members' homes. During these rotating stays, activities include visiting local ulama to gain knowledge. When you return from the gathering, you can study together using discussion or question and answer methods. The peak activity is the joint prayer (mujahadah) after the tahajud at midnight. Apart from routine activities, this group also organizes incidental activities involving the general public such as halal bihalal, seminars and commemoration of other Islamic holidays. Perhaps it was unique for a group of students of that age to have the courage to organize activities featuring religious and youth figures at sub-district level.

INTRODUCTION

The younger generation has an important contribution in building national character. However, the challenge for the younger generation in building national character is faced by the age of the younger generation itself, where the younger generation is a transitional age from adolescence to adulthood. At this time, of course, the younger generation does not have mature emotional stability, so they are often trapped in situations that lead to deviant behavior, such as drugs, free sex, brawls and other deviant behavior.

This statement is in line with Rusdiyani's statement which said that the younger generation is a generation that has relatively not yet reached the stage of mental and social maturity and therefore has to face conflicting emotional, psychological and social pressures. This results in a tendency for the behavior and lifestyle of the younger generation to be instantaneous, hedonistic, and tend to lose the identity that is rooted in their culture. This kind of phenomenon shows that the behavior and personality of today's young generation is increasingly moving away from the values of Pancasila and losing their identity as individuals rooted in the noble values of national culture [1].

Apart from that, it is feared that the behavioral tendencies of the younger generation due to their not yet reaching mental and social maturity could lead to the development of radicalism, especially among the younger generation themselves. This statement is reinforced by research conducted by Widyaningsih in 2017. The results of the research findings show that the younger generation is an age group that is vulnerable to exposure to radicalism and even becomes involved in acts of radicalism in the name of religion [2].

Guiding the younger generation can be done by instilling religious values, one of which is through youth organizations. Instilling religious values can be a solution because through instilling religious values the younger generation can understand the existence of a religion, where religion teaches goodness, so that the personality of the younger generation becomes better [3].

Starting from this idea, this research is important to carry out as an effort to find out how religious values are instilled, especially by youth organizations, in an effort to prevent deviant behavior in the younger generation. The locus of this research is the ANNAAS Young Generation Association of Wonosobo Regency.

The ANNAAS Young Generation Association is a young Islamic generation community that was founded in the Wonosobo Regency area of Central Java in 2003 and was formed by a group of Islamic students. This organization has the enthusiasm to learn more deeply and practice Islamic teachings correctly because Islam in Indonesia is divided into various groups of organizations that have differences in beliefs and practices. It is not uncommon for these differences to trigger conflict. Starting from this enthusiasm, the idea emerged to form a discussion group and agreed to actualize it in religious activities at school such as congregational prayers and dhuha prayers.

This research is in line with the research implementation policy at Semarang State University. The Technology Readiness Level (TKT) of this research is level 3, which is related to analytical studies related to the instillation of religious values in youth organizations as an effort to prevent deviant behavior of the younger generation.

Viewed from an age perspective, youth or the youth generation is someone who is entering a period of growth and development, namely in the age range of 16 (sixteen) to 30 (thirty) years. Youth or the younger generation is a generation that is often associated with value issues. In society, the younger generation has an identity as a potential generation. As the successor to the nation's struggle and as a human resource for nation development. Who can control the youth will control the future. The younger generation has a moral burden to fulfill the responsibilities given to them by previous generations. Apart from moral burdens, the younger generation is also faced with other problems such as juvenile delinquency, disobedience to parents/teachers, drug addiction, frustration, a bleak future, limited employment opportunities and other problems, including involvement in radicalism. The younger generation often clashes with existing values if they behave outside of these values [5].

Responses and assessments of the younger generation can influence the self-assessment of the younger generation themselves. This often creates a period of crisis which causes a tendency for deviant behavior in the younger generation [7].

Individual deviant behavior is often associated with social deviance. Social deviance is behavior that deviates from the social norms and values that exist in society. Social deviance can be carried out by anyone, both individuals and groups. Forms of social deviation include crime, fighting, promiscuity, consuming illegal drugs (narcotics), unnatural lifestyles and other similar forms. Deviant behavior whether on a large or small scale, broad or narrow can result in disruption of the balance of life in society [8].

In the perspective of social problems, adolescent deviant behavior can cause social problems because behavior, especially in adolescents, can be categorized as juvenile delinquency. Juvenile delinquency is an act that violates norms, rules or laws in society which is carried out during adolescence or the transition period from childhood to childhood.

The basis for forming youth organizations is the same principles, religion, ideology, interests and talents, or interests that do not conflict with statutory regulations [10]. Based on this explanation, the existence of youth organizations is important to provide guidance to the younger generation so that the younger generation does not fall into behavior that is contrary to statutory regulations.

Youth organizations can be said to be the beginning of a movement towards change. Through youth organizations, the potential of young people, such as critical attitudes, idealism, innovation, solidarity and high fighting spirit, can be developed. A positive attitude like this can encourage positive activities that can create the nation's next generation that the nation and state can rely on. Youth organizations are able to create conditions in such a way that people in the organization have attitudes, views and thoughts to achieve organizational goals as stated in the organization's vision and mission.

METHODS

The research approach used in this research is a qualitative approach. According to Creswell, qualitative research is flexible and the research design can change according to field conditions, so that

Data collection was carried out using interview methods and documentation studies. The research was conducted by interviewing leaders and members of the Wonosobo Regency ANNAAS youth organization. To obtain complete data, interviews were conducted with open and unstructured questions, so that respondents had the opportunity to answer questions according to what they experienced, thought and felt about strengthening religious values based on youth organizations in Wonosobo Regency. In this way, the answers given by respondents are truly complete and in-depth in accordance with the research objectives.

Analysis and interpretation of data was carried out by means of transcription and categorization, then described and interpreted, to obtain the meaning of the data according to the research objectives. Using data analysis techniques from Miles and Huberman, the data analysis method was carried out by (a) collecting data related to strengthening religious values based on youth organizations to prevent deviant behavior of the younger generation; (b) data reduction by sorting data according to the problem formulation; (c) data preparation, carried out by determining the data that will be included in the research results; and (d) conclusions are drawn by drawing conclusions according to the answers to the specified problem formulation [13].

RESULT AND DISCUSSION

Form of Strengthening Religious Values

The ANNAAS Young Generation Association is a young Islamic generation community that was founded in the Wonosobo Regency area of Central Java in 2003. This organization was formed by a group of Islamic students who have the same enthusiasm to learn more deeply and practice the truest teachings of Islam which is what Islam is all about. In Indonesia, it is divided into various groups of organizations that have differences in beliefs and practices. It is not uncommon for these differences to trigger conflict.

After several activities were carried out, this group called itself the ANNAAS Islamic Youth Association. The term ANNAAS is taken from the pronunciation of an-naas, the name of one of the letters in the Koran which means human. Philosophically, humans are the most perfect creatures equipped with reason and passion so they are not free from mistakes. Meanwhile, in terms of efforts to achieve their goals, this group believes that all desires must be obtained with effort and prayer, but the key to all of this is the intention. If the intention is noble and pursued seriously (*man jadda wajada*) it will be achieved. So this philosophy is expressed in the abbreviation ANNAAS, namely, if there is intention, there will be success.

In its first year, this group recruited members from students from the next generation, both from the same school and from other schools. Then in the second year many teenagers and young people from alumni or from other communities joined and took part in the activities that were part of the work program of the Annaas Islamic Youth Association. In the third year, precisely in 2005, ANNAAS began to spread to university students, this was in line with several members of the first generation entering several universities. Then because the members were no longer just students, in 2006 this group changed its name to the ANNAAS Islamic Young Generation Association.

Since this year, IGMI ANNAAS' activities have increased in scope. Not only educational and religious activities but also extending to sports development activities for nature lovers. Also participate

in raising social funds for disasters, orphans and the poor. To be attractive so that the name ANNAAS begins to be known by the public and the government. This is explained by the frequent accommodation by the sub-district government in several activities, such as handling disaster refugees and helping organize government events.

It was then agreed that in 2010 IGMI ANNAAS was submitted as a legal entity to the government through a notarial deed under the name ANNAAS Wonosobo Foundation. Since now, youth development has been increasingly improved. Several activities are increasingly developing in this era, expanding into arts and culture by holding the Youth Band Festival for the Head of the Wonosobo Regency Education Office. Starting this year, in terms of religious formation, routine activities began to study the Book of Tafsir Al-Ibris, which continues to this day.

In 2015, this organization underwent a name transformation from the Islamic Young Generation Association to the ANNAAS Young Generation Association.

To support activities to increase knowledge, IGMI ANNAAS also has a library with a book collection of more than 2,000 titles. These books are intended for members and the general public.

IGMI (Islamic Student Movement Association) ANNAAS has an important role in building the nation through its various contributions. IGMI ANNAAS is an Islamic student organization committed to developing youth potential in order to realize the ideals of a dignified, just and competitive nation. The following are some of the contributions of IGMI ANNAAS in building the nation:
