While in terms of pregnancy, recorded in 2001-2003, two thirds of women containing their first baby still in working status, and 80% still work a month or less.

Compared to 1961-1965, only 35% of women who worked with the status of pregnancy were present. This proves that the more advanced the mining of the times, proving also the negative things are also increasing. Indeed the statistics are taken from the United States, but these statistics can be a guide for the Indonesian nation to overcome the problem of prostitution. In addition, there is still a lack of protection and respect for human rights in Indonesia and can be a vulnerability for the future (Sumirat, 2016, p.20).

B. Women Exploitation in Prostitution Business and Its Protection

Business prostitution can be defined as a business that provides services to meet the desire or desire to have sex is not separated and very dependent on the existence of women. That is why the prostitution business is very dependent on women and can be said to be a place of exploitation of women.

Certainly a question for many people and even a question for women in itself why so many people who are not responsible to use and exploit women for money only and why also many women who want to sell and willingly exploited himself. Because basically many men who do not want to be in complications like infidelity that will cause many problems in the future and prefer to have sex without bonding in accordance with how to pay it. The second reason is to find the fastest and safest route. Many of the men willingly exploit women by paying it is because being able to hire women in the prostitution business is easy and fast. There are those who visit the website, go directly to the place and even directly pledged in a hotel or apartment. Another reason is that they want to get more fantasies than their wives and spouses. Because when they hire a woman they are free to treat and do whatever they like without having to think about what will happen to women because they think they have paid for it and do not have to worry about other problems.

The progress of the times has changed the way people think, it has been recognized that women today are not people who must always be at home in this case means only able to work and take care of the work at home as a wife (Pasya, p.1). Of course this change in the way of thinking of the community influences the activities undertaken by the women. Now finding women outdoors at night is not forbidden and hard to find. Of course also with the changes in behavior and activity itself has an impact on the emergence of positive or negative effects.

Referring to the results of research conducted by a professor from England Professor Louise Brown who examines the prostitution and trafficking of women in many countries in Asia. Professor who is a lecturer of Asian studies at the University of Birmingham, UK is also writing a book entitled Sex Slavery in Asia that classified PSK into 3 groups. The first is a group of beautiful women who deliberately proffered themselves into prostitutes for very high fees and rent. Women in this group have a very beautiful face. In addition they are also educated and usually fluent in English. They let themselves be exploited by traveling from one city to another in Asia. Women in this group are the fewest and hardest to find. Then the second group is a group of women who give up the exploitation of him by having a network, structure, and accompanied pimps in marketing. The second group is also found by the government of DKI Jakarta in Kalibata Mall. The number of women in this category of groups is more numerous and easier to find than the categories at the top level. And the last category of groups is women who do prostitution because of genuine economic urges. This group is very steal and very sad if attention. They peddle themselves in tombs and food stalls because they really need money and have no other way. This number is the largest number, because it is easy to find and the cost for this category is very cheap, ranging from Rp.5 thousand rupiah to tens of thousands.

Furthermore, it often happens and found negative labeling of gender assumptions and lead to imbalances and injustice (Huduri, 2014; Anis, 2018). But the basic reason why women who become the object of exploitation for the business of prostitution is not always their own volition and willingness, some are forced to volunteer themselves because of coercion and fraud against them. The form of coercion may come from the family, for example if a father forces his daughter to undergo a prostitution business to earn money and can help the family's economy.

Besides, this prostitution business is closely related to fraud. Generally women who are in the village or who desperately need a job are invited to follow the unscrupulous elements with promised jobs will be given, but what happens is they are traded. In Indonesia women trafficking victims are often used for the purpose of exploitation (Sastrivani, p.2). Because women's rights are scattered in various legislation through academic texts, the government provides a fair and just law to protect women from discrimination (Sapardjaya, et al, 2006, p.3). As a state of concern for the issue, a law No.21 of 2007 on the Eradication of Trafficking in Persons Act was signed in April 2007 (Nasution, 2008, p.51). If talking about protection and legal remedies against trafficking victims means talking about protecting the rights of every person trafficked to the same protection and treatment by law and law. Therefore, for any violations that have been committed and affected the victim, it must be guaranteed protection for the victim by law because the crime will always exist because of the social and humanitarian problems, as long as humanity and society persist, during which the crime will continue follow it (Hartati, 2013, p.1099)

Indeed, if discussed further and deeper, we can know that in fact the problem of exploitation of women in the prostitution business was not a trivial or a small thing. This problem is based on other criminal issues that occur and indirectly

become an additional force in the morning of the crime of human exploitation. For that country certainly can not silence and let a problem like this happen. The state in this case the government exercises its right to regulate society in various ways such as establishing legislation to limit irresponsible human behavior and against the law as well as existing norms of life, both the norms of decency, ethics, and religious norms.
